

This company will reinspect repairs done by others within four months of the original inspection. A charge, if any, can be no greater than the original inspection fee for each reinspection. The reinspection must be done within (10) working days of request. The reinspection is a visual inspection and if inspection of concealed areas is desired, inspection of work in progress will be necessary. Any guarantees must be received from parties performing repairs.

Note: The inspection was made of the structure as described, and indicated by diagram on page 1 of this report. Photo on front page is not a diagram. Inspections of fences, and/or detached structures that may exist on the property were not made unless otherwise stated in this report.

Note: This property was not inspected for the presence or absence of health related molds or fungi. By California law we are neither qualified, authorized nor licensed to inspect for health related molds or fungi.

Note: The inspection was made of accessible and visible areas only, and is limited to visible evidence only.

No opinion is made or implied of inaccessible areas, and no guarantee is made that infestations/infections, which are not visibly evident, do not exist.

Section I contains items where there is visible evidence of active infestation, infection or conditions that have resulted in or from infestation or infection. Section II items are conditions deemed likely to lead to infestation or infection but where no visible evidence of such was found. Further inspection items are defined as recommendations to inspect area(s) which during the original inspection did not allow the inspector access to complete the inspection and cannot be defined as Section I or Section II.

SECTION 1 - Visible evidence of infestation/infection or conditions resulting from infestation/infection.

1 Finding: Moisture damaged flooring noted in hall bathroom. Indicated on the diagram by "1", and some areas shown in Fig.1 images on the back pages of this report.

Recommendation: Replace flooring. Reset toilet on new wax ring using new bolts. Further inspect upon opening of enclosed areas. Replaced materials may not match existing.

2 Finding: Evidence of subterranean termites in cellulose debris (scrap wood, paper, etc.) found in the subarea, including live activity. Indicated on the diagram by "2", and some areas shown in Fig.2 images on the back pages of this report.

Recommendation: Remove all cellulose debris of size that can be raked. Chemically treat the soil as needed in accordance with the pesticide label to control infestation. Remove or cover all accessible termite shelter tubes.

SECTION 2 - Conditions that are conductive to infestation/infection.

3 Finding: Water heater drain valve leaks. Indicated on the diagram by "3", and some areas shown in Fig.3 images on the back pages of this report.

Recommendation: Install cap at valve outlet to eliminate dripping/leaking.

4 Finding: Loose toilet found in the master bathroom. Indicated on the diagram by "4", and some areas shown in Fig.4 images on the back pages of this report.

Recommendation: Reset toilet on new wax ring using new bolts. Further inspect upon opening of enclosed areas.

5 Finding: Wooden pier pads are in contact with soil in the substructure area. Indicated on the diagram by "5", and some areas shown in Fig.5 images on the back pages of this report.

Recommendation: This type of condition is commonly found with this type of structure. (Wood members appear to be pressure treated lumber.) Correcting these conditions does not appear to be practical. A periodic inspection is advised.

SECTION 3 - Items and notations that are not defined in either of the above sections.

Note: Moisture noted at kitchen cabinet area under sink. A test of sink faucet and dishwasher did not produce any visible leaks. A periodic inspection is advised.

Note: The structure contained furnishings and/or storage at the time of inspection. Sheppard Termite Services does not move furnishings, storage or any objects that obstruct access for inspection, and will not be responsible for conditions that may be concealed by furnishings, storage or any other objects. '

Note: Areas of the subarea were concealed by insulation, under floor vapor barrier and/or ducting.

Note: Soil in the substructure area was moist in areas, however, the moisture did not appear excessive at the time of inspection. A periodic inspection is advised.
