RELEASE--ANNEXATION CLAUSE IN  
WATER SERVICE/MAIN EXTENSION AGREEMENT

THAT WHEREAS, the City of Vallejo, a Municipal Corporation, hereinafter "City", entered into a written agreement with Larry T. Shaw, hereinafter "Owner", dated 6-27-79 for the supplying of water service to the premises located at Lot 2, Map of Thompson Subdivision, Unit No. 1, Cordelia; and

WHEREAS, said agreement entitled "Water Service/Main Extension Agreement" was thereafter recorded as Instrument No. 32065, on 7-2-79, in Book 54019-27, Official Records of Solano County, California; and

WHEREAS, said agreement contains a provision (Paragraph 2a(5) on page 3) that the Owner (including successors and assigns) perform all actions necessary to cause said premises to be annexed, within six months after date of demand, to the City of Vallejo; now, therefore,

The City of Vallejo does hereby release, acquit and discharge the Owner, and those claiming by, through or under him/her, from the condition to annex contained in said water service/main extension agreement, and only said condition, all other terms, conditions and stipulations of said agreement to be and remain in full force and effect until fully satisfied or otherwise extinguished by the City and the Owner, or by operation of law.

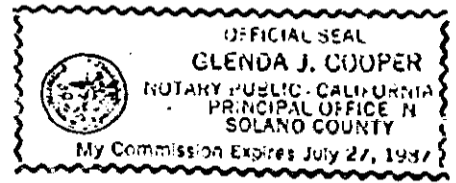
