MODIFICATION OF LAND CONSERVATION CONTRACT NO. 462

This agreement for modification of Land Conservation Contract No. 462, recorded in Book 1608, page 528, of the Official Records of Solano County, California, made and entered into this _____ day of _____, 1970, by and between BERTHA G. WEST

hereinafter referred to as "OWNER" and the County of Solano, a political subdivision of the State of California, hereinafter referred to as "COUNTY";

WITNESSETH:

A. OWNER and COUNTY mutually agree that paragraph 7, of the aforesaid Land Conservation Contract which reads as follows:

"7. In the event that an action in eminent domain for the condemnation of any land described herein is hereafter filed by any public agency, or when such land is acquired in lieu of eminent domain for a public improvement by a public agency or person, the within contract is null and void upon the date of filing of such action or upon the date of the acquiring of said land in lieu of eminent domain, and shall not thereafter be binding on the parties hereto. If only a part of the land under contract is affected by eminent domain or acquisition in lieu of eminent domain, the remaining land under the contract shall remain subject to the terms of the contract."

Shall be amended to read as follows:

"7. In the event that an action in eminent domain for the condemnation of the fee title of any land described herein is hereafter filed by any public agency or when such interest is acquired in lieu of eminent domain for a public improvement

by a public agency or person, the within contract is null and void upon the date of filing of such action or upon the date of the acquiring of such interest in lieu of eminent domain, and shall not thereafter be binding on the parties hereto. If only a part of the land under contract is affected by eminent domain or acquisition in lieu of eminent domain, the remaining land under the contract shall remain subject to the terms of the contract."

B. OWNER and COUNTY mutually agree that the aforesaid amendments shall be effective and binding upon the parties hereto as of the date of the execution of the aforesaid Land Conservation Contract.

C. OWNER and COUNTY mutually agree that all other provisions and terms of said Land Conservation Contract shall remain in full force and effect.


